General Rules of the ROOVEE system

I. PREAMBLE

1. These Terms and Conditions set out the general conditions and rules for use of the ROOVEE System by Customers.
2. Detailed regulations for individual Operators can be found in Section IV of these Rules and Regulations.

II. GENERAL CONDITIONS FOR THE USE OF THE ROOVEE SYSTEM

1. A condition of using the ROOVEE System is:
 - a. downloading the mobile application available for download on the website www.roovee.eu installing it and completing the registration procedure in the ROOVEE System by providing the required and correct personal data, accepting the terms and conditions which are set out in these Terms and Conditions and paying the initial fee in accordance with the table of fees and penalties of the relevant Operator. The funds accumulated on the User's account are subject to withdrawal up to the amount of the payment.
 - b. alternatively, creating an account and generating a telecode on <https://my.roovee.eu> and completing the registration procedure in the ROOVEE System by providing the required and correct personal data, accepting the terms and conditions which are set out in these Terms and Conditions and paying the initiation fee in accordance with the table of fees and penalties of the relevant Operator.
2. In order to register, the Customer must have an active e-mail account, an active telephone number and a telephone with Internet access and equipped with the Android or iOS version specified in the Google Play Store and App Store or a computer, tablet, telephone with Internet access.
3. The operator provides the latest version of the App with Android and iOS operating systems, in order for the App to work correctly, the latest available version must always be installed.
4. The operator provides access to the browser version of <https://my.roovee.eu> provided that the latest versions of the Safari, Chrome, Firefox, Edge browsers are used.
5. The customer rents the bicycle from the Operator on the terms and conditions specified in the Operator's Rules. The customer undertakes to comply with the terms and conditions of the Operator's Rules, in particular to pay the fees in accordance with the table of fees and penalties, to use the bicycle in accordance with the Operator's Rules and to report defects via the application, the <https://my.roovee.eu> system or by email: bok@roovee.eu.
6. As a card payment acceptor, ROOVEE S.A. is responsible for the services provided and complaints.

III. PROTECTION OF PERSONAL DATA

1. The Administrator of the Data processed through the ROOVEE System is ROOVEE S.A, Ryżowa 33a/7, 02-495 Warsaw.

5. The operator also reserves the right to terminate the contract with 7 days' notice, in particular if the customer provides incorrect data during registration, does not make payments on time, does not comply with the terms and conditions, steals or damages the bike.
6. The Operator reserves the right to amend the provisions of these Terms and Conditions. Information about the change will be sent to the e-mail address provided during registration and/or via notifications in the mobile application. Failure to inform the Customer of the non-acceptance of the change within 7 days from the receipt of the information by the Customer shall mean acceptance of the changes to the Terms and Conditions by the Customer.
